














Signal Quality distribution. Bad quality originates from degradation in coverage.












Nemo event call connected


Voice Quality Score is above acceptable standards for most part of the test.

ACCEPTANCE TEST PROCEDURE

CIVIL WORKS

Gravel in the fence does not meet the 10cm standard.

Plastic is visible in the site.





BTS CABINET

Cables in BTS Cabinet are not arranged properly.



IF cable is more than one loop.



Waveguide is not protected with putty and tape.




IF cable and other cables on the tower is loosely hanging.



Tape around cables on tower for protection is loosened and not done well.



Cables on towers are not in cable holder and are not arranged.



Cables are not properly laid, tie wraps are not cut, and cables are not in cable holder.



Equipment on tower is mounted with tie wrap; Bolts and nuts are not fully supporting the equipment.



Jumpers on antennas are not in cable holder and is not properly laid.



Jumper cables are bundled on tower; should be properly laid and looped.



Jumpers on antennas are not protected with putty and tape.



Cables are laid on the tower resting place; Improper installation.



GROUNDING

All four tower legs are not grounded, and the right cables are not used.



Tower legs are not grounded; Grounding cable used on tower legs is 25mm²



GROUNDING

Tower leg wrongly grounded and no cable shoes.



Tower leg not grounded.



GROUNDING

No busbar on tower; The grounding cable is 25mm²; The tie wrap used is not the proper one.



The grounding cable used is not the standard cable for tower.



RECOMMENDATION

Enable or check 2G EDGE parameter settings for internet connectivity.
Check parameter settings to reduce call setup time to <15 sec.
Optimized site RF antenna and/or check parameter settings to improve cell coverage radius to 5 km.
Site need bi-annual maintenance.
All metal tie wraps need to be changed to rubber tie wraps, to meet telecommunications installation standard.
All four legs of the tower need to be grounded.
Grounding cable on the tower need to be changed to 70mm ² coated grounding cable.
Waveguide on the satellite dish and jumper cables on RRUs need proper puttying and taping.
Cables running on resting place of tower need to properly placed into holders.
Cables on the tower need cable holders.
Grounding cables on the fence should be 25mm² or 35mm² coated.
Grounding test needs to be conducted for grounding system at the site to avoid damage during lightning strike.
Equipment with tie wrap on it needs proper bracket or else it will fall.
Increase crushed rocks in the site to atleast 10 cm height to avoid erosion.
